above conversion order shall be subject to the following conditions: -

i. The land converted for the above non-agricultural purpose shall not be used for any other non-agricultural purpose, without obtaining prior permission of the Prescribed Authority.

ii. If the applicant falls to use the land for the converted purpose within a period or extended period, if any, applicant shall be forfeited.

iii. No land as mentioned in rule 4 shall be used for any non-agricultural purpose.

iv. No part of the land converted for public utility purpose shall be used for any other non-agricultual purpose without valid permission from the Prescribed Authority.

v. The applicant is allowed to remove 3 trees from the converted land on the condition that he will plant three times of shady or densetrees in lieu of the removed trees within a year, failing which he shall be charged Rs 500 per year which is remained unplant in form of penalty in revenue head.
